RESOLUTION NO. 22

BE IT RESOLVED BY THE COMMISSIONERS OF King COUNTY DISTRICT NO. 34

AS FOLLOWS:

1. That the County Assessor has notified the Commissioners of Fine District Number 34 that the assessed valuation of real properties lying within the boundaries of said District for the calendar year 1959 is \$ 5,564,608.

2. That the attached hereto Exhibit "A" (by this reference made a part of this resolution) be and hereby is adopted as the budget of King County District Number 34 for the calendar year 1959.

3. That the Honorable Board of County Commissioners of King County, Washington, be and are hereby requested to make a levy for 1959 for said Fine District Number 34 of \$ 22,258.43.

4. That the County Treasurer of King County, Washington, be and is hereby authorized and directed to deposit and sequester the monies received from the collection of the tax levy specified in Section 3 above in the amounts and funds specified below:

A. \$ 3,845.00 into the Coupon Warrant Fund of said District

B. \$ 10,470.00 into the Expense Fund of said District

C. \$ 7,943.43 into the Reserve Fund of said District

D. \$ 22,258.43 to be used for the sole purpose of paying the interest and principal of said District's General Obligation Bonds heretofore

authorized and now outstanding. This levy to be without limitation as to rate or amount, and sufficient to pay the principal of and interest on said bonds as the same shall become due.

5. That one copy of this resolution together with Exhibit "A" be delivered to:
