RESOLUTION NO. 110/80

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF KING COUNTY  
FIRE DISTRICT NO. 34 APPROVING ANNEXATION OF CERTAIN  
TERRITORY

WHEREAS, there was filed with the Board of Commissioners of King County Fire District No. 34 a petition containing the signatures of sixty (60%) percent of the land owners of the area of land to be annexed for annexation of certain territory to said King County Fire District No. 34; and

WHEREAS, the sufficiency of the signatures on said petition has been certified; and

WHEREAS, a public meeting was held on approving said petition for annexation of territory at 7:30 p.m. August 6, 1979 at Headquarters Station, 16510 N.E. 79th, Redmond, Washington; and

WHEREAS, by Resolution No. 103/79 said District made known its approval of said petition and the filing of a Notice of Intent; and

WHEREAS, Notice of Intention to annex said territory, a legal description of the territory to be annexed, and maps of boundaries were filed with the King County Boundary Review Board with District Resolution No. 103/79, Boundary Review Board File No. 926; and

WHEREAS, by letter dated March 5, 1980, the Boundary Review Board did notify the District that such annexation of territory was deemed approved; and

WHEREAS, King County Fire District No. 34 concurs in said annexation;

NOW, THEREFORE, BE IT RESOLVED that the Board of Commissioners of King County Fire District No. 34 hereby annexes the following described territory, to-wit:

All of Section 25 and the North one-half (1/2) of Section 26, in Township 25 North, Range 6 East, W.M., and all of Government Lot 3 in Section 30, Township 25 North, Range 7 East W.M.

and more particularly described as follows:

Starting at the northeast corner of N.E. 24th and 244th Avenue N.E., going East to 276th Avenue N.E., then south to N.E. 16th Street; then east to 280th Avenue N.E., then South to N.E. 12th Street, then West to 276th Avenue N.E., then South to N.E. 8th Street, then West to 260th Avenue N.E., then North to N.E. 16th Street, then West to 244th Avenue N.E., then north to point of beginning.

Said annexation shall be effective as of the 31 day of December, 1980.

BE IT FURTHER RESOLVED that the District Comprehensive Plan is hereby amended to include said territory within the boundaries of the District.

BE IT FURTHER RESOLVED that the petition for annexation, together with seven (7) certified copies of this Resolution, be forwarded to the King County Council for such further action as by law is required.

ADOPTED this 2nd day of JUNE, 1980, by the Board of Commissioners of King County Fire District No. 34, King County, Washington, at a regular meeting thereof.
