**WHEREAS**, the Board of Commissioners of King County Fire Protection District No. 34 have concern that the official name of the District lacks any reference to the historical identify of the District and its long tradition to providing fire protection and emergency medical services to the citizens of Redmond and surrounding communities;

**WHEREAS**, the Board has discussed this concern and determined that a name which reflects the historical, geographic identify of the District and its citizens should be adopted as a common name for the District;


**WHEREAS**, the Board, after discussion, has determined that an appropriate common name for this fire district should be the Redmond Fire District; and

**WHEREAS**, the Board finds that the official name of the District, King County Fire Protection District No. 34, need not and shall not be changed; now therefore it is




