AMENDED RESOLUTION 217A/05

PROPERTY TAX LEVIES

2006

BE IT RESOLVED by the Commissioners of King County Fire Protection District 34 as follows:

1. That the County Assessor has notified the Commissioners of King County Fire Protection District 34 that the assessed valuation of real properties lying within the boundaries of said District for the calendar year of 2005 and tax year 2006 is \$3,777,829,741.00.
2. That the Honorable County Council of King County, Washington, be and is hereby requested to make a levy for 2006 for said King County Fire Protection District 34 of \$4,368,053.00.
3. That the County Comptroller of King County, Washington, be and is hereby authorized and directed to deposit and sequester the monies received from the collection of the tax levy specified in Section 2 above in the amounts and fund specified below:
 - A. \$4,035,056.00 into the Expense Fund of said District, 10-034-0010
 - B. \$332,997.00 into the G.O. Bond Fund of said District, 10-034-8510, to be used for the sole purpose of paying the interest and principal of said District's General Obligation Bonds heretofore authorized and now outstanding. This levy to be without limitation as to rate or amount, and sufficient to pay the principal of and interest on said bonds as the same shall become due.


