KING COUNTY FIRE DISTRICT 34 REGULAR MEETING- BOARD OF COMMISSIONERS August24,2005

I. Opening of Meeting

The regular meeting of the Board of Commissioners was called to order at 5:05 p.m. on August 24, 2005 at Station 11, located at 8450 161 st Avenue N.E., Redmond, Washington. Chairman Tom Johnston, Commissioner Peter Lucarelli and his wife, Millie Lucarelli, Commissioner Sherman Colson, Fire Chief Tim Fuller, Deputy Chief Andy Hail, Deputy Chief Loren Charlston, Deputy Chief Deb Ayrs, and Office Technician Debbie Gentry were present.

II. Public Comments - None

III. Attorney's Report

Attorney Kinnon Williams administered the oath of office to Peter Lucarelli as he was sworn in as King County Commissioner Position #1. District Secretary Anne Carlson will submit the Oath of Office and Resolution 216/05 to King County Records and Elections.

The Project Manager for Redmond Ridge e-mailed Kinnon Williams a list of estimated costs showing the district's responsibility at \$22,000 for low voltage and hardware to complete Station 18. Quadrant's cost is \$24,000. Kinnon has requested a breakdown to justify these additional costs.

Discussion: How much is the upgrade versus how much should have been in the original bid? Will this additional cost apply a credit, if entitled, for any existing contract items? Plans were reviewed and assumptions made based on the architect's experience. Should low voltage have been part of the original plans?

Andy has been working with Quadrant, and concessions have been made on the irrigation. No new apparatus is needed because they will be moved from another station.

<u>Surprises</u>: The architect did not include an equipment list to furnish the station in the original plans to Quadrant. From a cost perspective, it is better to wire for upgrades now than later. Door locks and security have been upgraded since the last station was built in 1995.

What furniture will be moved from another station? What are we going to do with the excess station? Lease it?

A special meeting is probably needed for construction issues, such as:

- 1. What should be done with the other station (move-in by tenant 1/1/06)
- 2. Inventory of that station
- 3. Keep Station 15 and 16 staffed until the end of the year (agreement with Sammamish)

It was decided that the commissioners would visit the Station 18 site anytime after September S".

An \$8,000 check was received from Kinnon Williams for a timber sale.

Redmond Public Works will advise what kind of trees to plant.

<u>Charlston</u> - Deccan Software PowerPoint Presentation. Bellevue currently uses the software, and Eastside Fire and Rescue is interested in it. We received a 10% discount for buying the program along with Woodinville and Kirkland.

Hail - Station 18 status: Punch list mid-October; move-in December

Monday night at 4:00 a.m., Redmond Ridge had a structure fire in a small family dwelling. The cause was a low voltage (30V) satellite power inverter that smoldered for hours in the crawl space. It was a three-year-old house with no sprinklers.

> Coordinate with KC Fire Marshal's office and see if it is appropriate to make a public safety announcement and/or public notice in the newsletter.

Fuller - The new paging/alert system will reduce response time by 30-40 seconds.

Meeting with Redmond Police on Friday to discuss Redmond providing its own dispatching. Can we afford it, and can we provide the same level of security?
