REGULAR MEETING – BOARD OF COMMISSIONERS  
March 15, 2006

**I. Opening of Meeting**

The regular meeting of the Board of Commissioners was called to order at 5:00 p.m. on March 15, 2006 at Station 11, located at 8450 161<sup>st</sup> Avenue N.E., Redmond, Washington. Chairman Thomas Johnston, Commissioner Sherman Colson (via telephone conference), Commissioner Peter Lucarelli, Fire Chief Tim Fuller, Deputy Chief Andy Hail, Deputy Chief Deb Ayrs, Attorney Kinnon Williams, and District Secretary Anne Carlson were present.

**II. Public Comments**

Ken Jauch – (Comments submitted by email to Secretary Carlson for inclusion in the minutes of the commissioners meeting of March 15, 2006 and attached to this document.)

John Lutz – Lives near Station 15. Felt the citizen committee's presentation was magnificent and logical. He would be negatively affected by Station 15's closure due to a heart problem.

Doris Gladney – Wondered why money could be spent on a fire station remodel when Station 15 was being closed. Chairman Johnston informed her that the station being remodeled is a City of Redmond station, not a district station. She asked if Station 15's proximity to schools was considered.

Laura Oliver – Feels that increased response times are not acceptable. Worries about wildland fires in the rural area. Wondered if the gas line was considered. Wants the right to vote for a levy lid lift.

Peter Tobin – Lives in Canterbury Woods. Thanked the committee for their hard work and the commissioners, especially Chairman Johnston, for fulfilling the duties of their election. He felt the human side of the issue has not been dealt with, just statistics. Does not care what call volumes are; just wants help there when necessary. Wants Station 17 opened by the City of Redmond and feels it is too expensive to close stations and relocate them to other areas. Wants the levy lid lift to go to a vote.

Muriel Burnstein – Her husband is ill and they moved from New Orleans to be close to their children. Has been happy with the fast response of Station 15 personnel in the past.

Mike Roy – Thanked the commissioners and chiefs, especially Deputy Chief Hail, for their hard work in researching the issues. The citizen committee wants Station 13 to house only an aid car; they feel Station 13's area would have coverage by other stations and jurisdictions. He referenced the committee's presentation contesting the presentation of the Fire Department.

Mike Craddock – Thanked the committee and Mike Roy for all their work. Feels that the gas pipeline construction concerns should delay Station 15's move. Construction on Highway 202 and increased traffic is a danger. Stated that Station 13's responses are mostly into Redmond and that the city transferred \$1 million from the fire department budget to Parks instead of building Station 17 when it was planned years ago.

Keith Brooks – Thanked Chiefs Hail and Fuller for providing data and the commissioners who have worked hard on this issue. Felt more work needs to be done. Is not opposed to paying more for better service and wants a levy lid lift vote.

Virginia Sollitt – Stated that people burn frequently in the area, causing particulate matter in the neighborhood. Does not feel people are very friendly in this area. Expressed concern about the amount of fireworks on the 4<sup>th</sup> of July. Would be willing to pay more for better emergency response.

Bill Oliver – Lives in Country Grove. Four years ago, a person was burning brush and the fire started a wildfire. Station 15 was there in two minutes but even so, the fire spread 50 feet within two feet of two houses.

E.G. Croner – Lives at 27004 NE Ames Lake Road. Station 14 can get to his house faster than Station 16.

Ron Dallas – Is unhappy that response times will increase.

Angela Latrell – Wanted to know why reserves were not kept to fund Station 15 because the commissioners knew five years ago that Sammamish was not interested in extending the contract and the funds would end.

Bob Foytz – Lives in Salish Estates. Wanted to know what happens next.

Frank Parchman – Emphasized that elected officials are required to maintain a level of service. To pit one neighborhood against another is wrong.

Sharon Tobin – Stated that the commissioners are giving the death sentence to people in the area when aid cannot reach them. Wants a levy lid lift vote.

Chairman Johnston told the group that Quadrant built Station 18 at no cost to District 34.

Commissioner Lucarelli stated that if significant district population and tax base in the southern area of the district had not been lost to Sammamish through annexation, the commissioners would not be in the situation of considering the closure of Fire Station 15. There has been a sizable population shift to the northern area of the district, through high population density construction, that must be addressed. He stated his appreciation for the committee's professionalism and hard work.

### III. Commissioners' Reports

Chairman Johnston read a statement regarding the work that has been done by the ad hoc citizen committee and listed the committee's four final points:

- Determine the costs of staffing four fire stations in the district and let the taxpayers decide
- Place an aid car only at Station 13
- Relocate the crew at Station 13 to Station 18
- When Station 17 opens, consider Station 13 for relocation

**Motion from Chairman Johnston to hire a consultant to measure voter support, within Fire District #34, of a levy lid lift for the purpose of staffing and equipping four fire stations, rather than the current three. Motion seconded by Commissioner Lucarelli, who spoke in favor of the motion. Commissioner Colson also spoke in favor of the motion. Motion passed unanimously.**

**Motion from Commissioner Lucarelli to relocate personnel and equipment from Station 15 to Station 18 on May 1, 2006 for a six-month trial period. Motion seconded by Commissioner Colson.**

**Commissioner Lucarelli spoke in favor of the motion.** He stated that when he became a commissioner, Station 18 was almost completed. Two of the most difficult things in the fire service are to site and build a new fire station, and the other is to close an existing fire station. In almost all circumstances, funding would never be requested to locate a fire station on a department's border. District 34 had no control of the changing demographics when Sammamish incorporated, and a large part of Fire District 34 chose to annex into the new City. After listening to staff and those at the public

hearings and in his professional opinion regarding the information, the best course of action at this time is to close Station 15 and transfer the personnel and equipment to Station 18. During a six-month period, positive and negative impacts will be consistently monitored and reviewed by fire department staff and the Commissioners. A district-wide survey will be conducted to determine the amount of support for a levy lid lift in order to support four fire stations rather than the current three stations. In terms of future planning, the commissioners are looking at consolidating Stations 13 and 15 into a better location so that the entire district will be better served through appropriately sited and deployed fire stations.

**Chairman Johnston spoke against the motion.** He would like to see the motion applied to moving Station 13, not Station 15.

**Commissioner Colson spoke in favor of the motion.** He stated that fire department administration has done a thorough study. He believes their information and feels the information can be looked at in different ways.

**Vote: Johnston – No  
Lucarelli – Aye  
Colson – Aye**

**Motion passed.**

**Motion from Chairman Johnston to postpone consideration of the three remaining citizen committee proposals until a financial impact study is considered by the Board. Motion seconded by Commissioner Colson. Motion passed unanimously.**

A blind survey will be done in District 34 by an outside consultant. Members of the citizen committee asked if they could have input to the survey. Commissioner Lucarelli stated that the consultant is given the task, and then develops and extracts the information without bias. The committee asked if they could know in advance when the survey would be done so they could mount a campaign. A request for qualifications will be published and hopefully proposals received by the April regular meeting. The next election would be in September or November. Submittal of a ballot measure must be 85 days before the election.

**IV. Executive Session 6:45 p.m. to 7:15 p.m. to discuss property acquisition. No action taken.**

**V. Attorney's Report – None**

**VI. Chiefs' Reports**

A. Fuller – There have been articles in the Eastside Journal and Seattle Times regarding the City of Redmond's levy lid lift vote on May 16, 2006. This addresses current city deficiencies.

B. Hail – The department's physical fitness committee recommended that new cardiovascular equipment be purchased for Station 18 to keep Station 15 whole in case the Training Division moves to Station 15. Free weights can be moved from Station 15 if necessary. Deputy Chief Hail informed the commissioners that the Training Division has decided not to recommend moving to Station 15 at this time because it is located too far away. They may relocate to a building next to Station 31 in Woodinville.

**VII. Approval of Minutes**

**Motion from Commissioner Lucarelli to approve the minutes of the February 22, 2006 regular meeting. Motion seconded by Chairman Johnston. Motion passed unanimously.**

**Motion from Commissioner Lucarelli to approve the minutes of the February 25, 2006 special meeting/executive session. Motion seconded by Chairman Johnston. Motion passed unanimously.**

**Motion from Commissioner Lucarelli to approve the minutes of the February 27, 2006 special meeting/public hearing. Motion seconded by Chairman Johnston. Motion passed unanimously.**

**Motion from Commissioner Lucarelli to approve the minutes of the March 14, 2006 special meeting/executive session. Motion seconded by Chairman Johnston. Motion passed unanimously.**

**VIII. District Secretary's Report**

- A. Budget Report – Chairman Johnston reviewed the district funds and February 2006 budget report from King County.
- B. Vouchers – Vouchers audited and certified by the auditing officer as required by RCW 42.24.080 and those expense reimbursement claims required by RCW 42.24.090 have been recorded on a listing that has been made available to the Board. As of March 15, 2006, the Board by a unanimous vote does approve for payment those vouchers included in the aforementioned list or lists and further described as follows:

- D. Legal Usage – There were 15.1 hours of legal use in February 2006.


