KING COUNTY FIRE DISTRICT 34 REGULAR MEETING - BOARD OF COMMISSIONERS April 17, 2007

I. Call to Order

The regular meeting of the Board of Commissioners was held at Station 11, located at 8450 161st Avenue N.E., Redmond, Washington on March 20, 2007. The meeting was called to order at 5:05 p.m. by Chairman Tom Johnston.

II. Roll Call

III. Approval of Minutes

- A. Motion from Commissioner Lucarelli to approve the minutes of the March 20, 2007 regular meeting. Motion seconded by Chairman Johnston. Motion passed unanimously.
- B. Motion from Commissioner Lucarelli to approve the minutes of the April 6, 2007 special meeting. Motion seconded by Chairman Johnston. Motion passed unanimously.

IV. Approval of Agenda

Motion from Commissioner Lucarelli to approve the agenda of the regular meeting of April 17, 2007. Chairman Johnston seconded the motion. Motion passed unanimously.

- VI. Executive Session 5:12 p.m. to 5:30 p.m. Discussion regarding potential litigation against the Fire District and property acquisition.

VII. Attorney's Report

A. The resolution to participate in the August ballot is due to King County on May 29, and submission of for and against statements in the voters pamphlet are due June 1. Applications for for/against committees need to be received by May 1 so those chosen may be notified by May 8.

Motion from Commissioner Colson to approve the special notice requesting applicants to serve on for and against committees. The notice will be put in the Redmond Reporter, on the district website, and in the newsletters of Trilogy, Ames Lake, and Redmond Ridge. Commissioner Lucarelli seconded the motion. Motion passed unanimously.

The election resolution will be addressed at the next meeting. Mr. Williams suggested talking with the Union and possibly doing some information mailing and public meetings. Deputy Chief Hail and Chairman Johnston will talk with the Union's Executive Board.

VIII. Chiefs' Reports

<u>Hail</u> – Upon second review, last week the State Building Code Council passed Redmond's ordinance requiring residential sprinklers in all new single-family construction in the city. There are 16 voting members, and the ordinance needed eight votes to pass. Olympia also received approval of a sprinkler ordinance required in developments with streets less than 20 feet wide.

The recruit academy should graduate nine out of the original ten recruits.

IX. Commissioners' Reports

- A. <u>Emergency Vehicle Access Corridors</u> Commissioner Lucarelli showed slides of access corridors in the area. The corridor on NE 60th and 228th Avenue NE is a public right-of-way, but there has been encroachment by a resident. The King County Sheriff would like access through any Knox gates. Deputy Chief Hail will look into dual keys.
- B. <u>Trilogy Homes located in Duvall but Serviced by KCFD 34</u> It is felt that Duvall would want to keep that area, and it is possibly not worth pursuing. Duvall does transports. It was agreed that fire administration will watch responses into the area and if there is an imbalance in reciprocal services, the district can address it then.
- C. New Financial Tracking and Strategic Planning Systems Commissioner Lucarelli attended a seminar where Bill Cushman of Snohomish County Fire District 1 presented financial planning software he developed. Commissioner Lucarelli suggested that Mr. Cushman be asked to present the program to the commissioners and staff. The model would allow the district to show the citizens how revenue is spent rather than just stating the district pays a certain amount of money to the City of Redmond. It was suggested that a retreat is necessary to talk about financial issues. Commissioner Lucarelli and Secretary Carlson will set up a meeting and invite department and city staff.
- D. <u>2005-2006 Budget Reconciliation</u> A report from the City of Redmond states that the district owes \$82,214 as reconciliation of the 2005-2006 budget.
