1. Call to Order-Regular Meeting

The regular meeting of the Board of Commissioners was held at 8450 161st Ave. N.E.., Redmond, WA on January 15, 2015. The meeting was called to order at 5:30 p.m. by Vice-Chairman Johnston.

2. Roll Call

3. Approval of Agenda

Motion made by Commissioner Lucarelli to approve the January 15, 2015 agenda as amended. Motion seconded by Commissioner Shanafelt. Motion passed unanimously.

4. Approval of Minutes

Motion made by Commissioner Shanafelt to approve the December 17, 2014 meeting minutes. Motion seconded by Commissioner Johnson. Motion passed unanimously.

5. Public Comments (4 minutes per person)

6. Call for Nomination of 2015 Chair

Motion made by Commissioner Lucarelli to nominate Commissioner Johnston as 2015 Chairman of the Board of Commissioners. Motion seconded by Commissioner Shanafelt. Hearing no further nominations, the nominations were closed.

Commissioner Johnston called for the vote. Commissioner Johnston was unanimously approved as Chair.

7. Call for Nomination of 2015 Vice-Chair

Motion made by Commissioner Lucarelli to nominate Commissioner Shanafelt as 2015 Vice-Chair- of the Board of Commissioners. Motion seconded by Commissioner Johnston. Hearing no more nominations, the nominations were closed.

Commissioner Johnston called for the vote. Commissioner Shanafelt was unanimously approved as Vice-Chair.

B. All Station Maintenance Report Results

Redmond continues to make efforts to collaborate with Public Works and their new facilities manager to determine the priorities of the results of the maintenance study.

C. Commercial Inspections/Interlocal Agreement

Todd Short, Assistant Fire Marshal, presented a map and report outlining approximately 15 commercial buildings in the District. After discussion regarding the cost and number of inspections needed, the Commissioners agreed that the District would absorb the cost of inspections. The cost of inspections would be based upon the same fee schedule used by King County and King County remains the enforcement entity for any compliance issues arising from inspections.

The WSRB will give credit for inspections performed, thus helping to raise the WSRB rating.

E. MDC Update

Chief Smith reported dashboard results among all three shifts. MDC usage continues to improve. Dashboard criteria remain a work in progress; vehicle inspections will be added.

A. PSERN Interlocal Prorationing Agreement

King County is seeking a .08 levy lid lift to be implemented over nine years to fund the aging emergency radio network system. It is not anticipated that Fire District 34's revenues will be affected by the agreement. Attorney Williams recommended approving the agreement.

Motion made by Commissioner Johnston to approve the Interlocal Agreement Concerning Fire District Prorationing Resulting from the PSERN Levy. Motion seconded by Commissioner Lucarelli. Motion passed unanimously.
