RESOLUTION NO. 297-16
2017 PROPERTY TAX LEVY

BE IT RESOLVED by the Commissioners of King County Fire Protection District No. 34 as follows:

1. That the County Assessor has notified the Commissioners of King County Fire Protection District No. 34 that the assessed valuation of real properties lying within the boundaries of said District for the assessment year of 2016 and tax year 2017 is estimated to be in the amount from the previous year to \$5,884,149,671.

2. That the Honorable County Council of King County, Washington, be and is hereby requested to make a levy for 2017 for said King County Fire Protection District No. 34 in the amount of \$7,000,000, as follows:

A. Expense Fund	\$6,882,033
B. Re-levy for Prior Year Refunds	\$ 117,967

3. Pursuant to RCW 84.52.125 the Fire District hereby protects the district's tax levy from pro rationing under [RCW 84.52.010\(2\)](#) by imposing up to a total of twenty-five cents per thousand dollars of assessed value of the tax levies authorized under [RCW 52.16.140](#) and [52.16.160](#) outside of the five dollars and ninety cents per thousand dollars of assessed valuation limitation established under [RCW 84.52.043\(2\)](#), if those taxes otherwise would be prorated under [RCW 84.52.010](#).

4. That the Treasurer of King County, Washington be and is hereby authorized and directed to deposit and sequester the monies received from the collection of the tax levy specified in Section 2 above into the Expense Fund of the District.
