RESOLUTION NO. 181/99

**ACKNOWLEDGING AUTOMATIC ANNEXATION OF THE CITY OF SAMMAMISH TO
KING COUNTY FIRE DISTRICTS 10, 27, AND 34 AND CONCURRING IN EXTENSION
OF AUTOMATIC ANNEXATION THROUGH DECEMBER 31, 2000**

WHEREAS, the City of Sammamish (the "City") will incorporate officially on August 31, 1999, and the newly-incorporated City is located in King County Fire Protection Districts 10, 27, and 34 ("Districts 10, 27, and 34"); and

WHEREAS, RCW 52.04.161 provides that the City is deemed to have been annexed by Districts 10, 27, and 34 effective immediately on the City's official date of incorporation and that the City shall continue to receive fire services from Districts 10, 27, and 34 through the remainder of the year of the City's official incorporation unless otherwise further extended; and

WHEREAS, RCW 52.04.161 provides that the City may extend the period of automatic annexation through the year following the official incorporation of the City if such extension is approved by resolution adopted by the City and by the board or boards of fire commissioners for Districts 10, 27, and 34, and shall be withdrawn from the fire protection districts at the end of this period; and

WHEREAS, the City has elected to extend the automatic annexation into Districts 10, 27, and 34 by Resolution No. R99-16; and

WHEREAS, the Board of Commissioners considers it to be in the best interests of District 34 and the public to have that portion of the City of Sammamish currently served by and within the boundaries of District 34 remain part of District 34 for the present time; NOW THEREFORE,

BE IT RESOLVED that the Board of Commissioners of King County Fire Protection District 34 hereby concurs with the City Council of the City of Sammamish in its decision to extend the automatic annexation to Districts 10, 27, and 34 through December 31, 2000;

AND FURTHER RESOLVED that the Board of Commissioners of King County Fire Protection District 34 ratifies continuation of the automatic temporary annexation of the City to King County Fire Protection District 34 pursuant to RCW 52.04.161 commencing on the date of the City's incorporation through December 31, 2000;

AND FURTHER RESOLVED, that copies of this Resolution be sent to the King County Assessor and Treasurer and to the City Council of the City of Sammamish for their records.
