2. That the Honorable County Council of King County, Washington, be and is hereby requested to make a levy for 2010 for said King County Fire Protection District 34 of \$6,993,443.00.
3. That the County Comptroller of King County, Washington, be and is hereby authorized and directed to deposit and sequester the monies received from the collection of the tax levy specified in Section 2 above in the amounts and fund specified below:
