#### 7. Reports of Attorney

#### A. FS 13 Septic System Project-

Attorney Williams advised that he has not been able to meet with County officials or staff in the last month as they have been involved with needed clean up and road closures and repairs due to the recent storms.

Attorney Williams also said that he met a septic designer from a firm that puts septic systems in "awkward" spaces and believes it would be worthwhile to have him visit the station and give an opinion on possible options. Ron Seng has already made contact and will have the designer (David Jensen) prepare a proposal for completing his own evaluation.

Attorney Williams will continue to follow the planned path of meeting with County representatives when they have the availability to do so.

Commissioner Pylant suggested that the Commission continue to postpone pursuing a possible alternate site for the station until the septic designer has offered input or a meeting with the County (Health Dept.) offers some direction.

#### 8. Reports of Commissioners

A. Stations 14 and 18 Seismic Upgrades – Commissioner Pylant advised that the next milestone in this project is a 90% design review which is scheduled for late March.
